Contaminants that may be present in source water include:

Microbial Contaminants: such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife

Inorganic Contaminants: such as salts and metals, which can be naturally-occurring or result from urban stormwater runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming

Pesticides and Herbicides: which may come from a variety of sources such as agriculture, urban stormwater runoff, and residential uses

Organic Chemical Contaminants: including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban stormwater runoff, and septic systems

This violation occurred because a direct link was not sent on the bills for the CCR in 2025. We corrected this issue on the December bill, and the system has returned to compliance. We received a public notice violation that covered the time period of **January 1st, 2024 through December 31st, 2024**. The required public notice was sent with the CCR. We corrected this issue on the December bill, and the system has returned to compliance. We also received 2 reporting violations surrounding lead service line inventories that covered the time period of **October 17th, 2024 through October 21st, 2024**.
